


STUDENT INTERNSHIP LIABILITY WAIVER and UNDERTAKING

do hereby execute this Student Internship Liability Waiver and Undertaking:

1. I will abide by the rules and regulations of my host Student Internship Company (hereinafter called host company) and will comply with what may be stipulated in a Memorandum of Agreement (MOA), should there be one. **If I violate any rules, regulations or policies of my host company that is a valid ground for termination of my internship therein, I understand that I may receive a failing grade of 5.00 for such internship depending on the gravity of offense and after observance of due process without prejudice to other disciplinary action that may be imposed by Lyceum of the Philippines University-Batangas (hereinafter called LPU-Batangas).**
2. I shall not hold LPU-Batangas liable and accept full accountability for any and all damages that I may cause to the properties, facilities or employees of my host company, or any injuries that I may suffer due to my own fault or negligence while performing my duties and responsibilities therein.
3. I understand that my host company is merely accommodating me as an intern for the purpose of completing my academic requirements. As such, I will not demand my host company to offer employment or hire me after my internship training therein;
4. I will not demand from my host company any compensation, remuneration, salary, allowance, or any form of incentives as payment for the services that I rendered as an intern therein;
5. My host company has the right to withdraw or terminate my internship training should I fail to comply or be found guilty of any infraction of the company's rules and regulations;
6. I acknowledge that there is no employer-employee relationship that exists between me and my host company. I understand that it is only a privilege to fulfill my student internship requirements in my host company.
7. As a pre-requisite to my internship training, I have already secured all the permits and clearances from LPU-Batangas necessary for students' internship such as but not limited to **Waiver, Student Internship Application Form, and most especially, a valid registration form as a proof of enrollment. Non-compliance thereto would render my internship null and void.**
8. **I fully understand that once I had been endorsed to a particular establishment, I cannot change host establishment for internship, unless there is a valid and reasonable ground to transfer, as maybe determined by the authorities of LPU-Batangas.**
9. I am fully aware that reservation of slot for internship including but not limited to onboard trainings, internships in other provinces and abroad requires payment. Once reservation is made, payment is imperative even I decided to back out. I further waive my right to reimburse what has been paid, if any.
